Before the Hearing

The Hearing will commence on Monday 6 March 2023 and conclude on Thursday 27 April 2023. It will
run for 27 days and will include a six day break over Easter. No additional days will be added.

Representative and expert witness details

2. If not already provided, full details of all representatives and expert witnesses must be circulated to parties on the Distribution List by 12 noon on Thursday 19 January 2023.

Hearing administration

- The Proponent (Minister for Planning) must liaise with the office of Planning Panels Victoria regarding:
 - a) A suitable venue in the Bass Coast area for Weeks 1, 6 and 7.
 - b) A suitable venue in Melbourne for Week 3 as rooms at Planning Panels Victoria are not available.
 - c) Hosting and managing the video conference of the whole hearing.
 - d) Establishing, hosting and managing online document sharing where all parties and submitters can access tabled documents through the course of the Hearing.

Circulation and sharing of documents

- 4. Documents must be filed electronically to all parties on the Distribution List.
- 5. File names should be as short as possible and written in the following format:
 - 'Party' 'document name'
- The Proponent must upload circulated documents to the document sharing platform as soon as practicable or provide a mechanism for parties to directly upload themselves.
- 7. Some protocols for all participants to observe in using the Distribution List include:
 - (i) The list is solely to allow relevant material to be circulated.
 - (ii) In circulating information, you need to provide the following note:

 "This document is of relevance to the Bass Coast DAL Committee and has been blind copied to all on the Bass Coast DAL Distribution List".
 - (iii) No defamatory or inappropriate material can be circulated, if any upload is deemed to be inappropriate, it will be taken off the document sharing platform.
 - (iv) Administrative type emails do not need to be uploaded.

Directions for the Proponent

- 8. The Proponent must circulate its summary of submissions, including place based and/or theme based by 12 noon on 21 December 2022.
- 9. The Proponent must file its opening Part A submission to parties on the Distribution List by **12 noon on 13 February 2023** that includes:
 - a) background to the DAL process, including chronology of events
 - b) strategic context and assessment
 - c) issues identified in submissions
 - d) any suggested changes in response to submissions
 - e) consultation processes
 - f) any other relevant information.

Note: Proponent's Part A submission will be taken as read by the Committee at the Hearing. The Proponent should allow time for questions about its Part A submission on Day 1.

- 10. Notwithstanding the discussion at the Directions Hearing, the Proponent is to make every effort to file peer review evidence on landscape and visual impact issues.
- 11. The Proponent is to instruct the authors of any of the technical reports to update their reports based on new or emerging information, especially if those authors are providing evidence.
- 12. Through its Part B submission, the Proponent is to provide a detailed response on how the DAL will ultimately be included in the Bass Coast Planning Scheme and how it would be implemented. This explanation should include information on how it is proposed the Minister for Planning and Council will undertake this, and who will be responsible for doing this work. It may be that the Proponent seek advice from Macedon Ranges Shire Council, Surf Coast Shire Council and the City of Greater Geelong in this regard.
- 13. The Committee seeks information on whether there is Minister for Planning determination and a 'Public Consultation Findings Summary' for the Bellarine DAL.
- 14. The Proponent must provide the Committee with a plan showing the location of all submitters by **13 February 2023**. The plan should identify submitters by submitter number, and not by name.
- 15. The Proponent in conjunction with Council (notwithstanding Council's position on the DAL), is to compile maps on boundary issues, that is, the submitters seeking to be included within or external to the settlement boundary. In this regard, the Committee requires a map of each town showing:
 - existing and proposed settlement boundaries
 - zoning of the land
 - existing and proposed Significant Landscape Overlays
 - the location of submitters land where they are seeking to be included within settlement boundaries (referenced by submitter number only)

Further, a table is to be provided that shows the submitter number, the requested change, the Council position and the Proponent position by **Tuesday**, **14 February 2023**.

Accompanied site inspection

- 16. An accompanied site inspection will be undertaken on Wednesday, 15 February 2023 and Thursday, 16 February 2023. The Committee will set aside days in the following week for the inspection in the case of inclement weather conditions.
- 17. The Proponent and Council must work together to provide a two-day itinerary for the Committee to undertake detailed accompanied site inspections.
- 18. Parties are to advise the Proponent at considers necessary to inspect by **Monday, 30 January 2023**. For ease of arrangements, it is preferable that sites nominated are publicly accessible.
- 19. The Proponent must provide a finalised site inspection itinerary with accompanying maps to Planning Panels Victoria by **Friday, 10 February 2023**.

Witness reports

- 20. A witness report must:
 - a) comply with the Guide to Expert Evidence (https://www.planning.vic.gov.au/panels-and-committees/planning-panel-guides)
 - b) not refer to any individual submitter by name if necessary, submitters should be referred to by submission number (*Note: it can refer to community groups, organisations, corporations and government agencies*)
 - c) be provided to the Committee as an unlocked document.

- 21. The Proponent must file its expert witness reports to parties on the Distribution List by 10.00am on **Monday, 13 February 2023.**
- 22. Parties must circulate their expert witness reports to parties on the Distribution List by 12 noon on **Friday, 17 February 2023**.

Meeting of experts

- 23. Expert witnesses in the areas listed below must meet after all evidence is lodged to prepare a statement of agreed opinions and facts. The nominated expert (usually the Proponent) should act as a chair for the meeting and coordinate arrangements and note taking.
 - a) Landscape and visual assessment
 - b) Land supply and economics
 - c) Planning/urban design
 - d) Ecology/environment.
- 24. The meeting(s) should be held:
 - a) at the discretion of the experts
 - b) by video or in person, as far as practicable, at a mutually convenient location
 - c) after the expert reports are circulated but before the Hearing commences.
- 25. The meeting(s) can only be attended by:
 - a) the experts being called to give evidence
 - b) a non-participating note taker if necessary
 - c) relevant staff from government agencies.
- 26. Advocates for parties instructing the experts must not attend the meeting(s).
- 27. The statement(s) of agreed opinions and facts should:
 - a) list the relevant experts in attendance, noting the experts present for any significant discussion point if some attendees are only there for part of the meeting
 - b) identify the key issues, including in relation to methodology, assumptions, results and interpretation of results
 - c) record the facts and opinions agreed and not agreed in respect of each issue and the reasons for any disagreement.
- 28. The statement(s) of agreed opinions and facts:
 - a) should not restate the evidence where appropriate, that evidence should be cross-referenced in the agreed statement
 - b) should, if possible, be fewer than five pages
 - c) should have numbered paragraphs
 - d) must be signed by all participants
 - e) must be circulated to parties on the Distribution List by 12noon the day before the first expert is to provide evidence in each area of expertise.
- 29. If any expert witness directed by the Committee to meet with any other expert is instructed not to reach agreement in respect of points of difference, those instructions must be reported in writing to the Committee by the expert witness.

At the Hearing

Submissions and information

30. Parties must present material at the Hearing electronically.

- 31. Electronic information must be circulated to parties on the Distribution List by **12 noon on the day before** the information is to be presented at the Hearing.
- 32. All information presented at the Hearing is a public document for the purposes of the Committee process unless the Committee directs otherwise.

Evidence and cross examination

- 33. Unless agreed by the Chair, evidence-in-chief must be no longer than 30 minutes *all expert witness reports will be read before the Hearing.*
- 34. As agreed at the Directions Hearing, the evidence of the lead expert in landscape and visual impact is may present for approximately 90 minutes.
- 35. An expert witness may refer to a presentation which summarises their evidence, but it must:
 - a) not include new evidence
 - b) be provided to parties by 12 noon the day before that witness is scheduled to appear.
- 36. Unless a specific direction is made about 'like' evidence, an expert witness can provide their response to other like evidence by 12 noon the day before that witness is scheduled to appear.
- 37. Parties, advocates and the Committee may question a witness.
- 38. During the Hearing, for scheduling purposes, the Committee will ask each party:
 - a) how much time they anticipate they will need for each witness
 - b) to keep to their anticipated time for each witness.
- 39. If cross-examining a witness, a party must:
 - a) be present for the whole of the giving of the evidence
 - b) ask clear and relevant questions, directed to matters of fact or professional opinion, that genuinely assist the Committee in understanding the issues
 - c) allow a witness time to explain their answer.
- 40. If giving evidence remotely, a witness must:
 - a) be alone in the room from which they give evidence and not make or receive any communication with another person while giving evidence except with the express leave of the Committee
 - b) inform the Committee immediately should another person enter the room from which they are giving evidence
 - not discuss their evidence with any other person during breaks in evidence when under crossexamination
 - d) not have before them any document, other than their expert witness statement and relevant supporting documents.
- 41. The Committee will regulate cross-examination.

Written submissions

42. A party who intends to supplement their original submission (without orally presenting that submission) must file their updated written submission to parties on the Distribution List by **12 noon on Thursday, 2 March 2023.**

Other information

43. As noted at the Directions Hearing, the Committee is trying to accommodate all submitters in a reasonable timeframe. The Committee has restricted all individual submitters to 30 minutes maximum, irrespective of whether they are being represented.

- 44. For all participants, the Committee directs that in submissions made at the Hearing, you make it very clear what actions or recommendations in relation to the Bass Coast DAL you are seeking in response to the Terms of Reference and the Letter of Referral.
- 45. All parties, submitters, and witnesses are to exhibit respectful behaviours to all participants at all times, no matter what your position might be. Inappropriate behaviour will not be tolerated. While the Committee has no power over the use of social media, it urges that any party using social media to discuss or highlight issues about this process, to do so in a manner that is always respectful to all participants.
- 46. Any other material a party wishes to present at the Hearing must be circulated to parties on the Distribution List by **12 noon on the day before** the information is to be relied on at the Hearing.
- 47. After presenting to the Committee, submissions and other material (preferably in MS Word) should be emailed to planning.panels@delwp.vic.gov.au as an unlocked document.
- 48. All information presented at the Hearing is a public document unless the Committee directs otherwise.

Closing submissions

- 49. The final two days of the Hearing will allow several parties to provide a closing submission.
- 50. A closing submission must not raise new matters but should respond to matters raised in other parties' submissions or evidence. If parties do not wish to take up that opportunity or require less time, that can be modified toward the end of the Hearing.

Recording Hearings and use of personal information

- 51. Parties must not record any part of an electronic hearing by any means without permission from the Committee.
- 52. In exceptional cases, the Chair may direct that the Hearing be recorded. A party who wishes proceedings to be recorded must make a request to the Committee at least five business days before the commencement of the Hearing, outlining its reasons.
- 53. If Planning Panels Victoria records an electronic hearing, any party provided with a copy of the recording on request must not publish or distribute that recording or use it for any purpose other than for the Hearing.
- 54. Parties must not record, keep, distribute or publish contact details of any other party obtained during an electronic hearing session, or use those contact details for any purpose other than for the Hearing.

Compliance with Committee directions

- 55. All directions must be complied with. It is an offence to not comply with a direction without lawful excuse. [section 169 of the *Planning and Environment Act 1987*]
- 56. If you anticipate being unable to comply with a direction (for example, meeting a deadline for the circulation of evidence), you must provide the Committee with advance notice, and a written statement explaining why you are unable to comply with the direction, and seek leave from the Committee to vary the direction.
- 57. The Committee may:
 - a) refuse to hear from anyone who fails to comply with a direction. [section 159(b)]
 - b) not accept evidence if leave to vary a direction for the circulation of evidence is not sought or granted.
