Sandown Racecourse Advisory Committee

The Minister for Planning appointed the Sandown Racecourse Advisory Committee (the Committee) on 2 March 2024 to consider draft Greater Dandenong Planning Scheme Amendment C229gdan that relates to a proposal to redevelop the Sandown Racecourse through a Comprehensive Development Plan and a Development Contributions Plan.

The Committee comprises:

The Committee will be supported by Chris Brennan, Senior Project Officer, Planning Panels Victoria. Mr Brennan will be the key point of contact throughout this process.

The Minister for Planning signed the attached Terms of Reference for this Committee on 2 March 2024.

The Terms of Reference provide the opportunity for a four-stage process to consider this matter.

- Stage 1 Initial assessment (Clauses 15 to 17)
- Stage 2 Public consultation (Clauses 18 to 22)
- Stage 3 Public hearing (Clauses 23 to 30)
- Stage 4 Outcomes (Clauses 31 to 32).

All members have declared no known conflicts of interest with this proposal. For noting, the Chair was the chair for the Moonee Valley redevelopment proposal in 2013 and the Flemington Hill proposal in 2015. Both matters had a two-stage process not dissimilar to these Terms of Reference.

In terms of Stage 1 for this matter, the Committee is keen to convene an inception meeting with nominated parties as below (and as noted in Clause 20 of the Terms of Reference) to consider relevant information and documents in order to gain an understanding of the proposal and the Amendment.
