About the Advisory Committee and this Report

About the Advisory Committee

The Golf Course Redevelopment Standing Advisory Committee (Advisory Committee) was appointed by the Minister for Planning in August 2019 to review and provide advice on Planning *Guidelines* for Golf Course Redevelopment and to advise on proposals for redevelopment of golf course land.

The work and scope of the Advisory Committee is guided by its Terms of Reference presented in Appendix C.

About this referral

On 9 May 2021 the Minister for Planning (the Minister) referred the proposed redevelopment of the Kingswood Golf Course to the Advisory Committee for consideration and advice.

Information on the referral and details of the Proposal (a draft combined planning scheme amendment and planning permit application, their supporting documents and a draft Development Plan) were listed in an Information Sheet from the Department of Environment, Land, Water and Planning (DELWP) dated June 2021.

The Proposal was initially placed on public exhibition for 30 business days between Monday 28 June and 11.59pm Friday 6 August 2021. This period was twice extended by the Minister for Planning to conclude on 3 September 2021.

Submissions were collected using Engage Victoria; 1650 submissions were lodged.

Appendix C: Terms of Reference: Golf Course Redevelopment Standing Advisory Committee

Version: 11 July 2019

The Golf Course Redevelopment Standing Advisory Committee is an advisory committee appointed under Part 7 section 151 of the *Planning and Environment Act 1987* to consider Planning Guidelines for Golf Course Redevelopment and proposals for redevelopment of golf course land within the Urban Growth Boundary (UGB) of metropolitan Melbourne.

Name

- 1. The advisory committee is to be known as the 'Golf Course Redevelopment Standing Advisory Committee'.
- 2. The advisory committee is to have members with the following skills:
 - a. Strategic and statutory land use planning
 - b. Urban design and landscape architecture
 - c. Environment and biodiversity
 - d. Traffic/transport planning.
- 3. The committee will include a Chair, Deputy Chair(s) and other appropriately qualified members.
- 4. The committee may seek specialist advice as appropriate.

Purpose

5. The purpose of the advisory committee is to:

- a. Review the draft Planning Guidelines for Golf Course Redevelopment, which includes a decision-making framework that will be used to assess proposals for the future redevelopment of surplus golf course land primarily within metropolitan Melbourne and advise how the guidelines can be given effect in the Victorian Planning System.
- b. Advise whether proposals for the rezoning of golf course land within the UGB of metropolitan Melbourne to facilitate redevelopment for urban purposes satisfy the planning guidelines and are consistent with state and local policy.

Background

- Golf is one of Australia's most popular organised recreational activities. There are over 1.2 million golfers Australia wide, and more than 300,000 Victorians played golf in 2015 at more than 350 golf clubs across the state.
- 7. A 2016 study commissioned by Golf Victoria found golf in Victoria contributes \$883.6 million in economic and health benefits to the Victorian community and there are 6,900 full-time equivalent jobs in the golf industry. Visit Victoria figures showed \$564 million in total expenditure from visitors to and within Victoria who played golf while visiting Victoria in 2017.
- 8. The sport is experiencing big changes in demand. Overall, traditional golf club membership is in decline and clubs are facing changing leisure patterns and increasing operating costs. Some golf clubs have been forced to merge or close. This trend has drawn developer interest in golf course land.
- 9. Victoria has more golf courses per capita than the rest of Australia. There is a need for some rationalisation and possible redistribution of golf course locations to match population growth and strengthen the viability and continuity of clubs.

- 10. Melbourne is under constant pressure from urban development and competing land use demands. Approximately 290 hectares of golf course land has been sold in recent years.
- 11. Golf courses provide social, environmental and cultural heritage values in metropolitan Melbourne:
 - a. 139 are located next to parks
 - b. 69 are on waterways, with some land subject to flooding
 - c. Sixty-five per cent of golf course land provides for biodiversity and native habitat.
- 12. Acting on Action 67 of the *Plan Melbourne 20172050* Implementation Plan, the Victorian Government established a taskforce to inform the development of a Planning for Golf in Victoria Discussion Paper. The discussion paper was published in July 2017 and was followed by a six-week engagement process.
- 13. The Planning for Golf in Victoria Discussion Paper proposed a suite of ideas to help navigate five key challenges for golf in Victoria. These were:
 - a. Participation challenge How will golf adapt and attract new participants?
 - b. Membership challenge Club membership has been in decline and operational costs are rising. How will golf clubs reverse this trend and balance a club's competing interest?
 - c. Supply and demand challenge Victoria has more golf courses per capita than the rest of Australia. How do we best provide for golf courses in the future?
 - d. Land use challenge Victoria is faced with a range of land use challenges. How do we protect the land values of golf courses and consider opportunities the land may present to help meet other land use needs?
 - e. Governance challenge Golf club and course administrators must address multiple challenges and increasing responsibilities as office bearers. How can we support the golf workforce to meet facility and land use challenges?
- 14. There was broad support from stakeholders, industry groups and the community for many ideas raised in the discussion paper, particularly for addressing the land use challenge presented by proposals for the rezoning and redevelopment of golf course land.
- 15. Recognising that golf course land, especially land within Melbourne's UGB can be considered for rezoning, the Victorian Government wishes to ensure new proposals for redevelopment are assessed according to consistent criteria outlined in a planning decision-making framework.

PROCESS

Part 1: Review of draft Planning Guidelines for Golf Course Redevelopment

Scope

- 16. The Department of Environment, Land, Water and Planning (DELWP) has prepared draft Planning Guidelines for Golf Course Redevelopment.
- 17. The advisory committee is to provide advice on the draft Planning Guidelines for Golf Course Redevelopment.

Stage 1 — Exhibition

- 18. DELWP will give notice of the draft Planning Guidelines for Golf Course Redevelopment for at least 20 business days. Notice will include:
 - a. all Victorian councils
 - b. Golf Victoria
 - c. Any person or organisation that made a submission to the Planning for Golf in Victoria Discussion Paper.

Stage 2 — Workshops

19. The advisory committee may conduct workshops or forums to explore issues or other matters. Any workshops or forums will be held in public.

Stage 3 — Outcomes

- 20. The advisory committee must produce a written report for the Minister for Planning providing the following:
 - a. an assessment of the draft Planning Guidelines for Golf Course Redevelopment and decisionmaking framework including any recommended changes
 - b. an assessment of submissions about the Planning Guidelines for Golf Course Redevelopment
 - c. recommendations on how the guidelines could be operationalised in the Victorian Planning System
 - d. a list of people who made submissions considered by the advisory committee
 - e. a list of people consulted or heard.

Part 2: Review of redevelopment proposals

Referral

- 21. The Minister for Planning or delegate may refer redevelopment proposals in one or more locations to the advisory committee for advice on future planning controls on the land.
- 22. The Minister for Planning may include land owned by the Victorian Government or local government where it enables a more comprehensive delivery outcome for the state. The inclusion of this land must be agreed to by the Minister for Planning as part of any referral.
- 23. In making a referral, the Minister for Planning or delegate must be satisfied that the proposed planning controls for the land make proper use of the Victoria Planning Provisions and are prepared and presented in accordance with the Ministerial Direction on the Form and Content of Planning Schemes.
- 24. A proposal may be in the form of changes to the planning scheme or a combined planning scheme amendment and planning permit.

Scope

- 25. The advisory committee may inform itself in anyway it sees fit, and must consider all relevant matters, including but not limited to:
 - a. the suitability of the proposal against the Planning Guidelines for Golf Course Redevelopment reviewed by the advisory committee
 - whether the proposed planning provisions make proper use of the Victoria Planning Provisions and are prepared in accordance with the Ministerial Direction on the Form and Content of Planning Schemes
 - c. relevant provisions of the *Planning and Environment Act 1987*, the Victoria Planning Provisions and *Plan Melbourne 2017-2050*
 - d. the relevant local planning schemes, including any exhibited or adopted planning scheme amendments
 - e. any adopted plans or strategies
 - f. strategic work by government in, or affecting, the area where the golf course land rezoning and/or redevelopment proposal is located, such as regional land use framework plans and sport and recreation facility provision plans
 - g. the views of project proponents and all relevant material prepared by of for project proponents, including any amended documentation

- h. the views of the relevant council in the area where a proposal is located
- i. the views of relevant referral and servicing authorities and Crown land management agencies
- j. all relevant material provided the advisory committee by all other participating parties
- k. all relevant submissions and evidence received
- I. any additional matters as directed by the Minister for Planning.

Process

Stage 1 – Exhibition

- 26. Following the referral of a redevelopment proposal, the advisory committee will liaise with DELWP to agree:
 - a. the public exhibition period dates
 - b. a directions hearing date (if applicable), and
 - c. the public hearing dates.
- 27. DELWP will give notice of the proposal for at least 30 business days. Notice will include:
 - a. direct notice to owners and occupiers who may be materially affected by the proposal
 - b. a notice in a local newspaper generally circulating in the area
 - c. direct notice to government agencies and servicing authorities
 - d. direct notice to relevant councils.
- 28. The advisory committee is not expected to carry out any additional public notification or referral but may do so if it considers it to be appropriate.

Stage 2 — Public hearing

- 29. The advisory committee is expected to carry out a public hearing and provide all submitters with an opportunity to be heard. Submitters are not required to have formal representation at the hearing.
- 30. The advisory committee may limit the time of parties appearing before it.
- 31. The advisory committee may prohibit or regulate cross-examination.

Stage 3 — Outcomes

- 32. The advisory committee must produce a written report for the Minister for Planning providing the following:
 - a. an assessment of each referred matter against the planning guidelines and decision-making criteria
 - b. an assessment of relevant state and local policy for each referred matter
 - c. an assessment of submissions to the advisory committee
 - d. any other relevant matters raised during the advisory committee process
 - e. recommendations to the Minister for Planning on whether a proposal should proceed and under what planning controls
 - f. a list of people who made submissions considered by the advisory committee
 - g. a list of people consulted or heard.

General — Applicable to Part 1 and Part 2

33. The advisory committee may meet and invite others to meet with it when there is a quorum of at least two members.

- The advisory committee may seek advice from experts when it considers this is necessary. 34.
- Submissions will be collected by the Office of Planning Panels Victoria (PPV) in accordance with 35. the `Guide to Privacy at PPV' and collected through the Engage Victoria website. Electronic copies of the submissions will be made available to the proponent, each relevant council and DELWP. Electronic copies may also be provided to other submitters upon request.
- 36. Petitions and proforma letters will be treated as a single submission and only the first name to appear on the submission will receive correspondence about advisory committee matters.
- 37. The advisory committee may conduct workshops or forums to explore design issues or other matters. Any workshops or forums will be held in public.
- The Minister for Planning may seek additional advice from the advisory committee consistent with 38. the Terms of Reference.
- 39. The advisory committee may apply to the Minister for Planning to vary these Terms of Reference in any way it sees fit before submitting its report to the Minister for Planning.
- 40. Following the submission of the report, the advisory committee may deliver an oral briefing to Department staff or the Minister for Planning.

Submissions are public documents

- 41. The advisory committee must retain a library of any written submissions or other supporting documentation provided to it directly to it until a decision has been made on its report or five years has passed from the time of its appointment.
- 42. Any written submissions or other supporting documentation provided to the advisory committee must be available for public inspection until the submission of its report, unless the advisory committee specifically directs that the material is to remain 'in camera'.

Timing

- Part 1: The advisory committee is required to submit its report as soon as practicable but no later 43. than 40 business days from the collection of submissions or 20 business days from the completion of workshop or forums.
- 44. Part 2: The advisory committee is required to submit its report as soon as practicable but no later than 40 business days from the completion of its hearings.

Fee

- 45. The fee for the advisory committee will be set at the current rate for a panel appointed under Part 8 of the Planning and Environment Act 1987.
- Part 1: The costs for the advisory committee of 'Stage 1: Review of Planning Guidelines for Golf 46. Course Redevelopment', are to be met by DELWP.
- 47. Part 2: The costs of the advisory committee of 'Stage 2: Review of redevelopment proposals', are to be met by project proponents unless the Minister for Planning directs otherwise.

DRAFT PLANNING SCHEME AMENDMENT C199KING – KINGSWOOD GOLF COURSE REDEVELOPMENT

On 20 November 2020, I received a request from AustralianSuper Residential Property No. 1 Ltd (the proponent) to consider a draft combined planning scheme amendment and planning permit application to facilitate the redevelopment of the former Kingswood Golf Course at 179-217 Centre Dandenong Road, Dingley Village for residential purposes.

The draft planning scheme amendment seeks to:

- Rezone the land from Special Use Zone Schedule 1 to the General Residential Zone Schedule 2.
- Apply the Development Plan Overlay Schedule 8 (DPO8) to the land to require the preparation of a development plan.
- Apply the Vegetation Protection Overly Schedule 3 to the land.
- Apply the Environmental Significance Overlay Schedule 6 (ESO6) to part of the land potentially affected by land gas migration and groundwater contamination from a nearby former landfill.
- Apply an Environmental Audit Overlay to part of the site that has been identified as being potentially contaminated land.
- Amend the Schedule to Clause 72.01 to make the Minister of Planning responsible for the consideration and approval of the development plan under the proposed DPO8.

The proposed planning permit application (under section 96A of the *Planning and Environment Act 1987*) is for the staged subdivision of land (823 lots), construction of dwellings on each lot less than 300 square metres, alteration of access to a road in a Road Zone Category 1, removal of native vegetation, removal of vegetation, use of the land and buildings and works for a display home centre, reduction in car parking, construction and display of signs and use of the land to use and consume liquor.

The proponent has also prepared a draft 'Former Kingswood Golf Course Development Plan' in accordance with the draft DPO8 and has submitted it for consideration in conjunction with the draft planning scheme amendment and planning permit application.

In accordance with the Golf Course Redevelopment Standing Advisory Committee (SAC) Terms of Reference, I refer this proposal to the SAC for consideration and advice.

I note that the terms of reference require me to be satisfied that the proposed planning controls for the land make appropriate use of the Victoria Planning Provisions (VPP) and are prepared and presented in accordance with the Ministerial Direction on the Form and Content of Planning Schemes.

On 1 March 2021, following the receipt of this request, I introduced Clause 44.08 Buffer Area Overlay (BAO) into the VPP. The BAO is to be used to identify buffer areas where there are potential offsite impacts from certain land uses and to ensure that use and development is compatible with these potential offsite impacts.

I note that the proposed planning scheme amendment seeks to apply the ESO6 to identify land that is potentially impacted by land gas migration and contaminated groundwater from a former landfill that adjoins the site. While I am generally satisfied that the proposed provisions are appropriate, I have written to the proponent and asked them to investigate whether the BAO would be a more appropriate tool to identify and mitigate impacts from the adjoining landfill, having regard to the guidance included in Planning Practice Note 92. I have asked the proponent to advise the Department of Environment, Land, Water and Planning (DELWP) on the outcome of this investigation prior to exhibition of the draft planning scheme amendment, planning permit application and development plan.

Officers from DELWP will liaise with Planning Panels Victoria on undertaking exhibition of the proposal in accordance with the terms of reference.

In addition to the scope set out in Clause 25 of the Terms of Reference, I request that the SAC also consider the following matters:

- a. The draft Former Kingswood Golf Course Development Plan.
- b. The draft planning permit application.

I also request that the written report include a draft planning permit.

The terms of reference require the committee to carry out a public hearing and provide all submitters with an opportunity to be heard. I direct that, if required, the public hearings can be held by video conferencing.

Following the receipt of the report, I will consider using my powers under section 20(4) of the Act to make a decision.

The costs associated with the process will be met by the proponent. Officers from DELWP will liaise with Planning Panels Victoria to facilitate this process.

1 About this guideline

The purpose of these guidelines is to provide guidance on preparing a proposal to redevelop a golf course to ensure a net community benefit and a quality outcome is delivered.

These guidelines should be used for developing a proposal to be either assessed through a planning scheme amendment process and/or a planning permit application.

These guidelines are intended as a resource for:

- proponents considering redevelopment of a golf course in Victoria,
- responsible authorities and stakeholders who provide advice and consider the appropriateness of the redevelopment of a golf course in any given location,
- any party interested in understanding the process for redeveloping a golf course in Victoria.

1.1 Golf courses in Victoria

Golf courses are a major land use and important to Victoria's culture and liveability. Golf course land typically has a number of special characteristics including:

- being large tracts of land often located in built-up urban environments;
- containing a number of environmental and biodiversity values;
- are large areas of open space;
- contributing to stormwater management;
- are managed either for the benefit of club members or the community;
- often limiting vehicle or sustainable movement due to the scale of the courses; and
- often containing heritage values.

Golf in Victoria is in transition as it responds to changing demographic and participation trends. Overall, traditional golf club membership is in decline and clubs are facing changing leisure patterns and increasing operating costs. Some golf clubs have been forced to merge or close. This trend has drawn interest in the redevelopment and repurposing of golf course land for other uses. Ensuring that these significant land holdings are appropriately developed to ensure positive social, economic and environmental outcomes is a primary concern of these guidelines.

1.2 Definitions

In these guidelines:

- **golf course** includes land used for maintenance, clubhouse and other facilities associated with a golf course
- **redevelopment of a golf course** means the use or development of all or part of a golf course for another use (for example, a residential use).

1.3 Application

These guidelines apply to:

- the preparation of an amendment to enable the redevelopment of a golf course.
- the preparation of an application for a permit, or an application to amend a permit, for the redevelopment of a golf course.

Golf courses subject to these guidelines include:

- freehold golf course land;
- golf course land owned by the Victorian Government or local government where the land ownership would permit conversion from an open space use;
- metropolitan or regional golf course land;

- the full or partial redevelopment of golf course land; and
- golf course land inside or outside a settlement boundary, including the Urban Growth Boundary.

Proposals seeking to rezone golf course land should be consistent with state and local policy objectives for particular locations. Any change to a defined settlement boundary or the Urban Growth Boundary raises policy issues not addressed in these guidelines. The process outlined in these guidelines does not supersede state and local policy objectives.

1.4 Golf Course Redevelopment Standing Advisory Committee

The Golf Course Redevelopment Standing Advisory Committee (GCRSAC) was established by the Minister for Planning under section 151 of the *Planning and Environment Act 1987* (the Act) to provide advice on proposals for the redevelopment of golf courses.

The Minister may refer the following matters to the GCRSAC for advice:

- An application for the redevelopment of a golf course that the Minister has called-in under section 97B, or has been referred under section 97C, of the Act.
- A request to prepare an amendment to a planning scheme to enable the redevelopment of a golf course.
- An application or request for authorisation under sections 8A or 9 of the Act to prepare an amendment to enable the redevelopment of a golf course.
- A proceeding related to an application for the redevelopment of golf course land that the Minister has called-in under clause 59 of Schedule 1 of the *Victorian Civil and Administrative Tribunal Act 1998*.

2 Legislative and planning policy context

2.1 Legislation

The *Planning and Environment Act 1987* (the Act) establishes the framework for planning the use, development and protection of land within Victoria and is implemented through the Planning Policy Framework (PPF), Local Planning Policy Framework, Victoria Planning Provisions (VPPs) and local government planning schemes.

2.2 State Planning Policy

These guidelines have been prepared in accordance with the purpose of the Planning Policy Framework (PPF) as outlined in the Victoria Planning Provisions at *Clause 71.02 'Operation of the Planning Policy Framework'* which seeks to 'ensure that the objectives of planning in Victoria (as set out in section 4 of the Act) are fostered through appropriate land use and development planning policies and practices that integrate relevant environmental, social and economic factors in the interests of <u>net community benefit and sustainable</u> <u>development'</u>.

The following state policies are considered relevant to golf course redevelopment proposals in Victoria

- **Clause 11 Settlement** These policies seek to ensure sustainable growth and development of Victoria and respond to the needs of existing and future communities through provision of zoned and serviced land for housing, employment, recreation and open space, commercial and community facilities and infrastructure. In particular:
 - Clause 11.01-15 Settlement broadly seeks to deliver networks of high-quality integrated settlements that have a strong identity and sense of place and are sustainable by responding to population growth and changing environments, support resilient communities, balance strategic objectives to achieve improved land use and development outcomes, preserve and protect features of rural land and natural resources, provide appropriately located supplies of residential, commercial and industrial land and improve transport network connections.
 - **Clause 11.03-65 Regional and local places** seeks to ensure integrated place-based planning by providing specific direction for the planning of sites, places, neighbourhoods and towns and consider the distinctive characteristics and needs of regional and local places in planning for future land use and development.
- Clause 12 Environmental and landscape values These policies seek to ensure planning helps protect the health of ecological systems and the biodiversity they support and conserve areas with identified environmental and landscape values. In particular:
 - Clause 12.01-1S Protection of biodiversity seeks to protect and conserve Victoria's biodiversity by ensuring that planning takes into account the impacts of land use and development on Victoria's biodiversity, including consideration of cumulative impacts, habitat fragmentation and the spread of pest plants, animals and pathogens into natural ecosystems.
 - Clause 12.03-15 River corridors, waterways, lakes and wetlands seeks to protect and enhance river corridors, waterways, lakes and wetlands by ensuring that development is sensitively designed and sited in order to respond to and respect the significant environmental, conservation, cultural, aesthetic, open space, recreation and tourism assets of water bodies and wetlands. Growth in established settlements must only be facilitated where water and wastewater can be managed.
 - **Clause 12.05-1S Environmentally sensitive areas** seeks to protect and conserve environmentally sensitive areas with significant recreational value from development that would diminish their environmental conservation or recreational values.
 - **Clause 12.05-25 Landscapes** seeks to protect and enhance significant landscapes and open spaces that contribute to character, identity and sustainable environments by ensuring development does not detract from the natural qualities of significant landscape areas.
- Clause 13 Environmental risks and amenity These policies outline planning should strengthen the resilience and safety of communities, aim to avoid or minimise natural and human-made environmental hazards, environmental degradation and amenity conflicts, ensure development and

risk mitigation does not detrimentally interfere with important natural processes and should prepare for and respond to the impacts of climate change. In particular:

- **Clause 13.01-15 Natural hazards and climate change** seeks to minimise the impacts of natural hazards and adapt to the impacts of climate change by considering the risks associated with climate change in planning and management decision making, directing population growth and development to low risk locations and ensuring siting and design of development minimises risk to life, property, the natural environment and community infrastructure from natural hazards.
- **Clause 13.02-1S Bushfire** seeks to strengthen the resilience of settlements and communities to bushfire through risk-based planning that prioritises the protection of human life.
- **Clause 13.03-15 Floodplain management** seeks to protect life, property and community infrastructure from flood hazard, the natural flood carrying capacity of waterways, the flood storage function of floodplains and waterways and floodplain areas of environmental significance or importance by avoiding inappropriately located use and development.
- **Clause 15 Built environment and heritage** These policies recognise the role planning plays in delivering land use and development outcomes that responds appropriately to its surrounding landscape and character, valued built form and cultural context in order to deliver liveable and sustainable cities, towns and neighbourhoods. In particular:
 - Clause 15.01-1S Urban design seeks to ensure urban environments are safe, healthy, functional and enjoyable and contribute to a sense of place by requiring development responds to its context, contributes to community and cultural life by improving the quality of living and working environments, ensures the interface between public and private realm protects and enhances safety, supports access to transport and provides landscaping that supports the amenity, attractiveness and safety of the public realm.
 - **Clause 15.01.-2S Building design** seeks to ensure building design outcomes contribute positively to the local context and enhance the public realm.
 - **Clause 15.01-3S Subdivision design** seeks to ensure the design of subdivisions achieve safe, attractive, accessible, diverse and sustainable neighbourhoods in new residential areas and in the redevelopment of existing areas.
 - **Clause 15.01-4S Healthy neighbourhoods** seeks to ensure neighbourhoods foster healthy and active living and community wellbeing through good design.
- **Clause 16 Housing** These policies recognise planning should provide for housing diversity and efficient provision of supporting infrastructure, ensure long-term sustainability of new housing and provide land for affordable housing. In particular:
 - **Clause 16.01-1S Integrated housing** seeks to promote a housing market that meets community needs by increasing the supply of housing in existing urban areas, ensuring an appropriate quantity, quality and type of housing is provided, ensure housing developments are integrated with infrastructure and services and high quality social housing is delivered.
 - **Clause 16.01-25 Location of residential development** seeks to ensure new housing in designated locations offer good access to jobs, services and transport by increasing the proportion of new housing in designated location in urban areas and reduce the share of new housing in greenfield and dispersed development areas, encourage higher density housing development, ensure an adequate supply of redevelopment opportunities within established urban areas and facilitate residential development that is cost effective in infrastructure provision and use, energy efficient, water efficient and encourages public transport use.
- **Clause 17 Economic development** These policies recognise planning plays an important role in provide for a strong and innovative economy and contributes to the economic wellbeing of the state and foster economic growth.
- **Clause 18 Transport** These policies promote an integrated and sustainable transport system that is safe and provides access to social and economic activities, facilitates economic prosperity, contributes to environmental sustainability and coordinates reliable movements of people and goods.
- **Clause 19 Infrastructure** These policies promote the development of social and physical infrastructure that should be provided in an efficient, equitable, accessible and timely manner, recognising social needs for a range of accessible community resources. In particular:

- *Clause 19.02-6S Open space* seeks to establish, manage and improve a diverse and integrated network of public open space that meets the needs of the community.

3 Guidelines




Figure 1: Indicative assessment pathway

When preparing an amendment to a planning scheme or application for the redevelopment of a golf course, the following steps should be followed in accordance with Figure 1.

- 1. Consider whether the land should be redeveloped.
- 2. Identify the strategic direction for the site.
- 3. Determine what assessments and approvals are required.
- 4. Document site values, constraints and opportunities.
- 5. Engage the community.
- 6. Develop a land use concept that delivers net community benefit.
- 7. Deliver a quality outcome.

3.1 Step 1: Consider whether the land should be redeveloped

The following questions should be addressed in establishing whether golf course land should be converted to another use:

- Does the land tenure allow for conversion?
- Is the golf course surplus to golfing?
- Are there economic alternatives to conversion?
- Should the land remain as open space?

Proponents should confirm the ownership of the land and that it is available for conversion and document any title or legal restrictions on its future development.

To assess whether the golf course is surplus to the needs of golfing, a proponent will need to identify:

- Whether the course has been identified in a regional golf facility plan as a course that should remain or is a candidate for conversion to another use. If there is no relevant golf facility plan, consider:
 - the demand for golf courses in the region and whether the course is located in an area currently under-supplied or over-supplied with golf courses
 - whether there is capacity for the golf course to be improved to incorporate contemporary design standards and facilities.
- Whether the proposal delivers improved golf facilities consistent with Victoria's Golf Tourism Strategy and any relevant golf facility plan.

The proponent should commission independent economic advice on:

- whether golf is likely to remain viable at the course taking into account:
 - the course facilities and layout
 - the club patronage and financial status
- the broader economic implications of the proposal.

Golf course land, particularly in metropolitan areas, presents a rare opportunity for governments to purchase a significant land parcel for community or public use. Where golf course land has been determined as being surplus to the needs of golfing, the land should be offered at first instance for acquisition to the Commonwealth and Victorian governments and local governments. This involves three considerations as outlined below:

- State-owned public golf course land will be offered under the Victorian Government Landholdings Policy and Guidelines (2017). All other golf course land owners should be encouraged to make genuine effort to investigate whether any government authorities are interested in acquiring the land by engaging with local and/or state government.
- Local government planning authorities should assess redevelopment proposals in accordance with strategic planning for the local area, including identification of future public land requirements.
- Local government planning authorities should identify the public land requirements generated by the proposed urban development made allowable as a result of the golf course land conversion.

3.2 Step 2: Identify the strategic direction for the site

Establishing the strategic direction for the site is a key step to developing a concept for the site. Any concept for the site should begin with the question: what does policy say is the best use for this site?

The strategic direction for a proposal should consider, the following:

- The level of access to transport and activity centres.
- The local open space network or wildlife network.
 - Whether the proposed conversion is consistent with relevant policies and strategies including:
 - the Planning Policy Framework in the Victoria Planning Provisions or relevant planning scheme
 - Metropolitan Planning Strategy
 - any metropolitan open space strategy or regional open space strategy
 - the Yarra Strategic Plan, if adjacent to the Yarra River
 - any relevant waterway, catchment, or flooding strategy
 - any approved council open space strategy
 - any approved council housing strategy.
- Whether proposal has the potential to contribute to broader strategic priorities, such as:
 - Active Victoria Framework
 - Water for Victoria Water Plan
 - Any regional *Integrated Water Management Plan* or the achievement of water sensitive urban design principles
 - Victorian 30-Year Infrastructure Strategy
 - Protecting Victoria's Environment Biodiversity 2037.

3.3 Step 3: Determine what other assessment and approvals are required

All other applicable assessment and approvals for the proposal based on the relevant legislation should be identified. Consider all relevant legislation, including:

- Aboriginal Heritage Act 2006
- Environment Effects Act 1978
- Commonwealth Environment Protection and Biodiversity Conservation Act 1999
- Heritage Act 2017

Determine:

- who are the relevant decision makers
- the level of effort and rigour required to document the site values and constraints
- the program for the preparation of documentation and engagement.

3.4 Step 4: Document site values, constraints and opportunities

The values, constraints and opportunities at the golf course land must be clearly documented. The values, constraints and opportunities will be identified by the proponent, relying on technical studies and feedback from community engagement.

The following matters should be considered, as relevant, when identifying the values and constraints of a site:

- the environmental values of the site, including biodiversity values, habitat connectivity and the strategic biodiversity significance or role of the site in the local or regional ecosystem, including the relevant bioregion
- the community values of the site, including community facilities providing for active or passive recreational pursuits, the catchment of the community using the site, whether the site is accessible to the public
- the open space values of the site, including whether the site is accessible to the public, or if it has broader landscape values through the provision of tree coverage and green areas
- any environmental hazards including hazards that are mitigated by the way the golf course land is currently managed, such as flooding or bushfire hazard
- the cultural heritage values of the site, including aboriginal heritage values and other cultural heritage values
- any contamination, including any known or likely sources of contamination that may exist due to historical uses or through the management of the golf course land
- the site's integration with existing infrastructure, such as transport networks (public transport, road, pedestrian and bicycle routes), stormwater infrastructure, electricity transmission links
- the site's relationship to nearby residential areas, rural or green wedge areas including its interface with residential development.

The opportunities for the site should consider:

- integration with existing open space networks and recreational facilities
- restoration of environmental values, including protection of biodiversity, native vegetation, water ways, water bodies and wetlands
- opportunities to increase resilience to climate change and natural hazards, including a design response that may increase the community's resilience to bushfire and flooding events and sea level rise
- additional community facilities
- educational and health facilities
- a range of dwelling types including affordable housing
- tourism facilities

• introduction of environmentally sustainable measures and design features, such as the generation of renewable energy, water sensitive urban design, wastewater reuse, and waste reduction.

3.5 Step 5: Engage the community

Develop a comprehensive community consultation program and commence consultation before preparing detailed designs. The purpose of this consultation is to:

- assist the community to understand the need for the golf course land conversion
- allow the community to provide input to identification of site values and constraints
- allow the community to contribute to identification of opportunities and ideas for the golf course land conversion
- foster open channels of communication between the proponents and the community.

3.6 Step 6: Provide a land use concept that delivers net community benefit

Proposal to convert golf course land must provide a net community benefit and a high level of sustainability.

As well as an overall community benefit the proposal should:

- deliver a net increase in public open space
- deliver improved environmental values
- deliver a net community benefit for the community surrounding any redeveloped course.

The following factors should be considered to determine if, the proposal provides a net community benefit and environmental benefit:

- whether a proposal:
 - contributes to achieving state or local government policy objectives and strategies
 - delivers improved golf facilities and whether these are accessible to the public
 - provides additional public open space, sporting or recreational facilities or makes financial contributions to improve or develop regional or local sporting facilities and open space
 - protects and enhances the wider open space network and ecological connectivity
 - rehabilitates degraded land or mitigates existing environmental risks
 - contributes to local housing priorities such as the provision of affordable or social housing, sheltered housing or crisis accommodation
 - delivers connected walking and biking paths and general improvements to pedestrian and cycling connectivity
 - delivers social or community infrastructure such as libraries, medical or education facilities
- the impacts on local transport and traffic networks
- any proposed commercial uses, and whether any potentially out of centre commercial uses are proposed
- how the proposal will integrate with surrounding land uses, infrastructure and services
- whether the proposal incorporates climate change adaptation measures for communities and the environment.

Other factors may also be relevant considerations depending on the circumstances of the golf course land and the proposal.

Proponents are encouraged to liaise closely with the planning authority in an iterative and negotiated process to arrive at a final position regarding the net community benefit of the proposal.

3.7 Step 7: Deliver a quality outcome

Any proposal to convert golf course land must deliver a high quality outcome.

To ensure net community benefit, the redevelopment of golf course land should achieve the following:

- at least 20 per cent of the land area to be developed is set aside as publicly accessible useable open space that contributes to an integrated open space network. This land may be encumbered by easements, reservations, heritage, vegetation or other conditions and make provision for land to be used for passive or active recreation
- enhance and protect state, regional and locally significant environmental assets and biodiversity corridors
- landscaping that delivers an appropriate amount of tree canopy cover (excluding active sporting areas) to mitigate urban heat effects and is at least equivalent to, or greater than the surrounding area
- active transport links are provided into the surrounding area and must be provided on the golf course land proposed for redevelopment.

The strategic response

The Planning Policy Framework (PPF) outlines objectives for land use and development in Victoria. For the redevelopment of golf course land, the strategic response must ensure it delivers on these objectives as well as addressing, where relevant, matters set out in this section.

The strategic response should address the recommendations of reports which identify the:

- environmental
- ecological
- arboricultural
- landscape
- viewshed
- archaeological
- historical and cultural values and features of the site
- transport impacts with transport management proposals.

The strategic response should include a site analysis and design response demonstrating a response to site opportunities and constraints, with particular regard to:

- the physical constraints of the site.
- public open space requirements.
- the interface with adjoining uses and developments.
- identified heritage assets.

as well as any adopted policy or code for residential development and subdivision.

Housing

Where a redevelopment proposal seeks to include housing development, the strategic response should encourage the provision of affordable housing, and show or make provision for:

- a range of dwelling types to cater for a variety of housing needs.
- management of amenity impacts to ensure the reasonable amenity of future residents of the site.

Built form

The strategic response should include Urban design guidelines for the land including but not limited to:

- building envelopes, massing, heights and setbacks.
- treatment of car parking areas and orientation of garages.
- building orientation and location, car parking areas, public roads, vehicle access locations, pedestrian and bike paths and areas and locations of private and public open space.
- the preferred design and interface treatments to public open spaces within and adjacent to the land.
- development setbacks from internal streets.

• treatments to achieve reasonable amenity to public urban spaces, streetscapes and pedestrian and bicycle paths including overshadowing and wind tunnelling effects.

Open space

The strategic response should show or make provision for the following matters, as appropriate:

- open space integrated into the site which includes not less than 20 per cent of the developable area of the site as publicly accessible useable open space that contributes to an integrated open space network. This land may be encumbered by easements. reservations, heritage, vegetation or other conditions and make provision for land to be used for passive or active recreation.
- existing trees identified in an Arboricultural report to be retained.
- a landscaping concept plan including a maintenance program.

Circulation and movement

The strategic response should address matters raised in any Transport Management Plan prepared by an appropriately qualified expert addressing the following matters, as appropriate:

- the impact of the development on the arterial and local road network.
- mitigation works required on the road network.
- funding responsibilities.
- connections to adjoining land.
- road hierarchy.
- cross sections.
- proposed transport management devices.
- bicycle network.
- public transport routes.
- pedestrian links.

The strategic response should make provision for the internal road and path network for pedestrians, bicycles and vehicles to create a high level of permeability through the site by considering:

- the primary access and egress from the land for vehicles from [specified roads] to the standards of the relevant road authority.
- future pedestrian links into the site to connect nearby open space.
- links to public transport services.

Environmental Management

The strategic response should address the requirements of any Environmental Assessment of the land, including the following matters as appropriate:

• A flora and fauna survey, which identifies existing vegetation or habitat of international, national, state, regional or local significance required to be protected and enhanced in adjacent waterways or the subject site.

Natural hazards

The strategic response should address the requirements of any Natural Hazard Assessment of the land, addressing the following matters as appropriate:

- a bushfire risk assessment that identifies the bushfire risk at the landscape and site scale and identifies appropriate bushfire mitigation measures.
- flood risk assessment that identifies the risk of flooding, predicted impacts of sea level rise and identified appropriate mitigation measures.
- geotechnical hazard assessment.

Social Impact

The strategic response should address the requirements of any Social Impact Assessment Report which considers the following as appropriate:

- An assessment of the adequacy of existing social and community infrastructure to serve the land.
- Any additional social and community infrastructure to be provided as part of the redevelopment.
- Any community infrastructure contribution to be made in connection with the development.

Heritage and Archaeological Survey

The strategic response should address the requirements of any Heritage and Archaeological Survey and show or make provision for the following matters as appropriate:

- cultural heritage including places and objects.
- any buildings to be retained under any conservation controls.

Subdivision

The strategic response should show the following:

- indicative lot layout, roads and pedestrian connections and public open space.
- any proposed staging of development including staging of infrastructure and open space delivery.

Planning mechanisms

An appropriate planning control should be used to guide the development of the land to ensure a quality outcome is delivered in line with the objectives outlined in these guidelines.

Circumstances relating to each golf course site vary. There are several planning tools that can be used to ensure the development of the land achieves net community benefit and the requirements of the guidelines.

There is existing guidance about the use of planning tools that should be considered when applying a planning controls to the land, including for requirements relating to open space and infrastructure contributions.

Potential planning controls available to a planning authority include:

- a Development Plan Overlay (DPO),
- an Incorporated Plan Overlay (IPO),
- a Precinct Structure Plan (PSP),
- a Section 96A combined planning scheme amendment and permit application process.

Appendix F: Procedural issues

F.1 Declarations

Declarations relating to Australian Super

Ms McMillan and Ms McGuinness declared that that their superannuation funds are with Australian Super. In response to concerns raised at the Directions Hearing, the Advisory Committee considered whether this amounted to a perceived or actual conflict of interest that would prevent them from hearing this matter. Ms McMillan and Ms McGuinness considered the scale of the fund, their relative interest in the fund, their level of influence over investment decisions, and the number of years before they will receive a superannuation benefit and concluded:

- their relative interest in the fund is insignificant
- their influence over investment decisions at the super fund is extremely limited
- the financial contribution of the project to their anticipated retirement benefits is extremely small
- there is an extremely remote connection between any recommendation of the Advisory Committee and their future retirement benefits.

The Chair of the Advisory Committee agreed with this assessment and noted the benefit of having members who contributed to the development of the *Planning Guidelines for the Conversion of Golf Course Land to Other Purposes* assist in assessing this matter. It was proposed that Ms McMillan and Ms McGuinness would continue to hear this matter.

Declaration regarding conflict Ms McMillan and Council witnesses

Following the parties confirming their expert witness details as required under Direction 4, Ms McMillan advised the Advisory Committee:

Council has indicated that it will be calling two expert witnesses from Biosis Pty Ltd, Jeff Yugovic and Kristen Campbell. I declared at today's Directions Hearing that my company does contract work for Biosis. While I am not currently working directly with Mr Yugovic or Ms Campbell on any projects, in order to avoid any perceived conflict of interest I withdraw from the matter.

The Advisory Committee advised, on 21 October 2021, that Ms McMillian would remain a member of the Advisory Committee, but would not take any further part in assessing this referral.

F.2 Adjournment of the Hearing

First adjournment

Following the consideration of two adjournment requests by Kingston City Council and the Dingley Village Community Association, at the Directions Hearing of 31 August 2021, as well as possible diary clashes, the Hearing was rescheduled to commence on Monday 8 November 2021.

The Advisory Committee agreed that the COVID-19 restrictions in place at the time of the request inhibited opportunities for site inspections by parties, including expert witnesses and the Advisory Committee itself. The Advisory Committee advised:

... However, as the Hearing process extends until mid-November, the Advisory Committee anticipates the consequential issues can be overcome with the cooperation of the Proponent to facilitate inspections and with the Advisory Committee foreshadowing that it will allow the filing of supplementary witness statements by expert witnesses should that be necessary.

The Advisory Committee does not accept the request for adjournment by the Dingley Village Community Association so it can hold a public meeting or for consultation with the Proponent. The number of submissions indicates awareness of the proposal, the opportunity for making a submission and this process. The filing of material as requested ahead of presentations to the Hearing will provide the Dingley Village Community Association opportunity to communicate with its members and the uploading of material onto the Engage Victoria website, will provide information to the public at large.

At the Directions Hearing, the Proponent advised it could provide the additional material sought by the Advisory Committee (as outlined in the attached 'Further advice to guide Proponent's submissions') by 8 November 2021 and suggested that as a possible date for commencement of the Hearing. The Advisory Committee notes Council's strong preference to commence on 22 November 2021, a date initially suggested because of an Advisory Committee member diary conflict. Subsequent, to the Directions Hearing that diary conflict has been resolved. The Advisory Committee accepts that the Hearing process may need to accommodate arrangements to deal with restricted site access due to COVID-19 restrictions.

The Advisory Committee, determined the Hearing would begin on Monday 8 November 2021.

Second adjournment

The Advisory Committee held a second Directions Hearing for the above matter on 15 October 2021 by video conference.

Following the consideration of a second adjournment request from Council (Tabled Document 19), the Hearing was rescheduled to commence on Monday 15 November 2021. As a consequence, the timings provided in the Advisory Committee's Directions issued on 14 September 2021 were revised and an updated version 2 of the Directions were attached, along with an outline of the hearing process.

F.3 The prospects for Hearings in person

The Advisory Committee had indicated at the first Directions Hearing its preference to hold the Hearing in person. This was not possible, the Advisory Committee explaining:

Unfortunately, there appears to be no real prospect that a Hearing could be held in person this year given the COVID rules as they apply generally including physical distancing restrictions and vaccine requirements, the risk of disruption from a positive case attending the Hearing, and employment obligations on the Advisory Committee members. The Hearing will proceed by video conference using the Zoom video conference platform.

F.4 Is the course surplus to golfing?

Submitters expressed concern that the Advisory Committee had indicated at the Directions Hearing and in advice to the Proponent that submissions on whether the course was surplus to golfing were not required.

On 21 October 2021, the Advisory Committee specifically directed the Proponent to address whether the course is surplus to golfing needs.

F.5 Concerns about process

In a letter dated 21 July 2021 (received by email 27 July 2021) Mark Dreyfus QC MP, Federal Member for Isaacs, raised concerns about the Advisory Committee process. The concerns raised related to:

- how petitions are dealt with
- the requirement to request a Submission Coversheet for hard copy submissions
- the possibility of extending the submission deadline by an additional two weeks or more.

The Advisory Committee advised:

The Advisory Committee welcomes submissions through either of two pathways:

- As an individual submission (from a single person, organisation, association, or business) with submissions lodged online or by hard copy.
- As part of a joint submission either:
 - a small group of people known to each other that provide a single submission
 - as part of a larger submission where people act together to reinforce the same message to the Advisory Committee such as a petition or a pro-forma submission.

Your concerns about the Advisory Committee's processes touch on three points:

- individual acknowledgement of a submission
- incorporation of the submission into the Advisory Committee's deliberations
- what you say is discouragement of civic engagement.

Each individual submission receives a written acknowledgment of the submission. For individual submissions contact details are collected to ensure we meet our privacy obligations regarding collection and use of submissions, and to effectively communicate those obligations to the submitter, either as part of the online process or with a coversheet for hard copy submissions.

Any petition or set of pro-forma submissions lodged with the Advisory Committee is dealt with as if it were a joint submission under the section 21A of the *Planning and Environment Act 1987*. That is, any acknowledgement of the submission and subsequent notices will be provided to the person nominated in the submission or the person first named on a petition, and an opportunity to be heard is afforded to that person. The contact details about each participant on a joint submission are not required.

For the Committee to individually acknowledge each signatory to a joint submission it would need to set rules to ensure the contact details of each signatory were included in the petition. This is not something typically required for petitions, and is often not provided with pro-forma submissions. It could limit the willingness or ability of people to make, or participate in, joint submissions.

It is always the case that a Committee considers the detail and the merits of each and every submission (and evidence), whether they are made by an individual or a joint submitter. Whether the material it receives is treated as a single submission signed by 2,000 people or 2,000 identical 'individual' submissions does not alter the merits of the submission.

The purpose of exhibition of the proposed Kingswood Golf Course redevelopment proposal is to invite civic engagement in the process through individual or joint submissions, online or by hardcopy to assist in informing the Advisory Committee's advice to the Minister for Planning. The Advisory Committee welcomes public participation in its processes.

Your concerns about the access to the hardcopy coversheet are noted. We will investigate how we can smooth this process. We do not make it available online because people with online access are able to lodge using the simpler and instant online submission process.
