## Suburban Rail Loop East Precincts Standing Advisory Committee

We are writing to you because you made a submission to the Suburban Rail Loop (SRL) East draft Structure Plans and draft Planning Scheme Amendments.

The Minister for Planning appointed the Suburban Rail Loop East Precincts Standing Advisory Committee (Committee) to provide timely and independent advice on referred SRL East precinct planning matters. The Minister referred specific matters to the Committee on 7 July 2025.

A copy of the Committee's Terms of Reference and the Minister's referral letter are **attached**. They will also be available on the Planning Panels webpage [here](#) shortly.

This letter:

## Draft Structure Plans and Draft Planning Scheme Amendments

The Suburban Rail Loop Authority (SRLA) has prepared draft Structure Plans, implementation plans and the following Planning Scheme Amendments for each SRL East Precinct:

The draft Amendments propose to implement the draft Structure Plans by introducing planning policies and controls to guide the development of land in the Structure Plan areas and give effect to the key directions and outcomes of the Structure Plans.

The SRLA is the planning authority for these amendments.

## The Committee's role and scope

The Committee will:

- consider the referred matters and hear from the SRLA and submitters in an independent forum
- be informal and not like a court
- give fair, unbiased advice to the Minister for Planning, the SRL Minister and the SRLA about the referred matters.

### Referred matters

The referral letter identifies the referred matters on which the Committee's advice is sought. The referred matters include:

- general issues common to all precincts (general issues)
- issues relating to the specific precincts.

### Referred material

To date, no referred material has been received apart from the referral letter itself (including the attachment titled 'Specific matters for referral'). ### Out of scope matters

Clause 16 of the Committee's Terms of Reference states that the following matters do not fall within the scope of the Committee's assessment, unless the referral states otherwise:

- matters relating to the strategic justification for the SRL Program
- matters documented within the SRL Structure Plan Guidelines including the matters identified in clause 10 of the Terms of Reference, namely:
  - the boundaries for the preparation of the draft Structure Plans
  - the timeframe for which the draft Structure Plans are to be prepared
  - the population and employment objectives to be adopted for the purpose of informing aspects of the planning processes to be undertaken in the preparation of the draft Structure Plans
  - the strategic policy context as applicable to the SRL East Precincts
  - the precinct Visions informing the preparation of the draft Structure Plans
- matters concerning the delivery or funding of community infrastructure to support the land use and development proposed by the draft Structure Plans.

At the Directions Hearing, the Committee will:

- clarification of the scope of referred matters
- consider Hearing venues and site inspections
- discuss whether precinct specific Directions Hearings may be required
- answer questions people have about the Hearings and the Committee process.

- wish to raise procedural issues
- have questions about the Committee process.

### Main Hearings

Clause 20 of the Terms of Reference state the Committee is not expected to carry out a public hearing, but may do so if deemed necessary to consider the referred matters.

The Committee considers that public Hearings are necessary to enable the Committee to undertake its task. It proposes to conduct seven Hearings:

- a general issues Hearing
- six Precinct Hearings.

The purpose of the Hearings is for people who made submissions in relation to a referred matter to speak to those matters, and to hear from the SRLA and the Councils about the referred matters.

Clause 21 states the Committee may conduct concurrent hearings. The Committee considers some concurrent hearings are required if the Committee is to meet its reporting timeframes in clause 42 of the Terms of Reference.

The attached Key Information includes an indicative hearing schedule including details of the proposed concurrent hearings.

Unless otherwise specified by the Minister for Planning in the referral letter, the following matters do not fall within the scope of the Committee's assessment:

- a. Matters relating to the strategic justification for the Program.
- b. Matters documented within the Structure Plan Guidelines including the matters identified in clause 10 above.
- c. Matters concerning the delivery or funding of community infrastructure to support the land use and development proposed by the structure plans.

For the purposes of clause 16c. above 'community infrastructure' includes any community or public buildings, facilities, places, areas or services including (but not limited to) those capable of being funded from a development infrastructure levy or through an infrastructure contributions plan or for which a State government department, agency or other public authority is responsible for providing under any Act.

The attachment to the referral letter includes items headed 'community infrastructure' and 'public open space', both of which potentially fall within 'community infrastructure' as defined in clause 16.

The Committee will seek clarification at the Directions Hearing in relation to the advice sought in relation to community infrastructure and open space, including whether advice is sought on:

- the scope of community infrastructure and open space proposed to be provided (as outlined in the publicly available Structure Plans)
- site selection for proposed community infrastructure and open space
- strategies and actions outlined in the Structure Plans relating to community infrastructure and open space
- delivery mechanisms and funding mechanisms for community infrastructure and open space.

Planning Panels Victoria (PPV) may:

- provide a copy of your material with all contact details to the Proponent, government agencies and other parties to the Hearing
- provide a copy of your material to any other person who requests it (your personal information will be removed first)
- provide a copy of your material to relevant government Departments if needed for preparing briefings to the Minister for Planning or the SRL Minister.

## Hearings

Your submissions and any other material that you present to the Committee will be a public document, available for public inspection (refer to clauses 36 to 38 of the Committee's Terms of Reference).

The Committee will conduct the Hearings in person and using video conferencing. Hearings by video conference have special privacy requirements. If you choose to participate in the Hearings, you should be aware a link to the Hearings will be published on the internet, and third parties will be able to join the Hearings and observe.

Hearings may be recorded and copies of any recording may be provided to the parties via the document sharing platform.

The Committee can hear submissions or accept material on a confidential basis, provided this would be fair to the other parties to the Hearings. If you want to make your submissions or provide material to the Committee confidentially, you will need to ask permission from the Committee Chair and provide reasons why the Committee should treat your submissions or material confidentially.

## The Committee reports

Reports will include a list of the names of people and organisations who made submissions to the Committee. Reports may include direct quotes from submitters. The reports may be published on the internet if the Minister for Planning decides to publicly release the reports.

## After the Committee has reported

When the Committee has reported to the Minister for Planning, the SRLA and the SRL Minister, your material will only be publicly available through a freedom of information request.

## Requesting copies
