The Committee issued its written directions on 13 February 2024.

Timetable and Hearing arrangements

The Committee has prepared the attached Version 1 Hearing Timetable taking into account further advice from parties on experts and availability since a Version 2 Gantt chart indicative program was emailed to parties on 12 February 2024. The Committee has relied on details from request to be heard forms, verbal advice at the Directions Hearing, and further written advice from various parties in seeking to accommodate availability constraints of advocates and experts. While there has been no significant change from the indicative program, the Committee expects further Timetable revisions will be required given the complexity of this matter. This may include detailed scheduling of witnesses for roundtables that run across multiple days given the Committee is aware that some experts have unresolved availability issues.

If you or your experts are not available for a session you wish to participate in, please advise Planning Panels Victoria by email to planning.panels@delwp.vic.gov.au as soon as possible. Parties are encouraged to adopt a collegial approach to identifying changes by contacting each other directly where a suggested change may affect another party's allocated time.

The Committee confirms that the Hearing will proceed in a hybrid format, with Hearing Room 1 at Planning Panels Victoria available for the entirety of the Hearing for those participating in person. Planning Panels Victoria will work with the VPA to provide a video link for those wishing to participate online.

Additional directions

The Committee makes the following further directions, in addition to those issued on 13 February 2024.

- In light of the Victorian Planning Authority no longer calling drainage evidence as advised in the email from Ashurst on 15 February 2024, the Committee directs that Melbourne Water appoint one of its drainage experts, being either Jamie Carroll or Paul Clemson, to chair the conclave meeting on drainage.
- Parties wishing to nominate sites for the Committee to inspect as part of its unaccompanied site inspection must do so in writing to Planning Panels Victoria by 12 noon on Friday 23 February 2024.
- Parties who are yet to advise the Committee and parties of their expert witnesses must do so by 12 noon on Wednesday 21 February 2024.



Declarations

Since the Directions Hearing, Member Carlisle has identified that Galileo Group is calling evidence from Tim McBride-Burgess who is a Victorian Planning and Environmental Law Association (VPELA) board member. Member Carlisle declared she was a VPELA board member at the Directions Hearing, noting that a number of advocates were also board members, and undertook not to discuss this matter with fellow board members until after the Committee's report was submitted.
