Council circulated its without prejudice permit conditions on Thursday 11 September 2025. The Committee will ask parties to comment on the permit conditions during the roundtable discussions, as relevant to each topic of discussion.

As advised in the Committee's letter of 20 August 2025, parties will have an opportunity to provide written closing submissions and comments on the without prejudice permit conditions by 12 noon on Monday, 29 September 2025.

Issues raised in submissions

The Committee's letter dated 20 August 2025 outlines the scope of the Committee's role.

The Committee notes Council's submissions address the mandatory nature of application requirements. The question of whether the controls are mandatory or discretionary is not a referred matter. The Committee will not be making a ruling on this and asks parties to proceed on the basis that a permit can be issued and a merits assessment will be undertaken. Parties should present their submissions accordingly.

Purpose of roundtable discussions

To explore unresolved issues relating to the matters referred to the Committee.

Discussion process and focus

The Committee will facilitate a discussion focused on the matters under consideration, including:

 - Adaptation Guide 6 Sustainable
 - Clause 53.24-7.4 (Environmentally sustainable design)
