Distinctive Areas and Landscape Standing Advisory Committee – Referral 3 Draft Bass Coast Statement of Planning Policy

This letter:

- informs you about the final composition of members of the Committee

The Committee

Kathy Mitchell AM (Chair), Alison McFarlane (Deputy Chair), and Members Mandy Elliott, Rebecca Finn, Ian Hamm, Natasha Reifschneider, and Jessica Tulloch will consider Referral 3 to the Distinctive Areas and Landscape Standing Advisory Committee (DALSAAC). The key areas of expertise of the nominated members relevant to consideration of this matter are included as Attachment 1.

The Chair and Member Hamm were involved in the Surf Coast DALSAAC and Member Hamm and Member Reifschneider were involved in the Bellarine Peninsula DALSAAC.

It will be rare that all members will be sitting together at the same time. The Chair and the Deputy Chair will likely sit most of the time, noting the Terms of Reference at Clause 14 provide for a quorum of two, so long as the Chair or a Deputy Chair are present. For example, the environmental issues will be shared between Members Elliott and Reifschneider, the planning issues between the Chair, the Deputy Chair and Member Tulloch. The landscape assessment issues will include Member Finn and Aboriginal cultural and Traditional Owner issues will include Member Hamm. All issues that arise during the course of the Hearing will be shared with all members. All members will have access to documents and will be fully informed of proceedings and issues.

At times, some members may be online, while others may be in person, or a combination of both.

While many of the experts are known to the Committee through the planning and environment profession, the members have not identified any actual conflicts of interest and at this stage, have no declarations to make.

The Committee will be assisted by Hayley Becker, Project Manager and Gabrielle Trowse, Project Officer of Planning Panels Victoria.
