Filing documents

- 1. The VPA must host and manage an online document sharing platform. The platform must:
 - a) Be set up by 12 noon on Monday 1 September 2025.
 - b) Include folders for documents from each party and a folder for tabled documents.
 - c) Allow a party to upload documents directly.
- 2. The VPA must email all parties on the distribution list to provide advice on how to access and use the online document sharing platform by **12 noon on Monday 1 September 2025**.
- 3. Documents must be filed electronically by uploading them to the document sharing platform. When uploading documents, a party must email all other parties on the distribution list to inform them of the document(s) that have been uploaded.
- 4. Documents must be available to access and download from the document sharing platform until the date the report is submitted by the Advisory Committee (Committee). Each party is responsible to retain any documents before that date.
- 5. Documents must meet the following requirements:

Referred issues

- The issues on which the Committee's advice and recommendations are sought are set out in the letter of referral from the VPA dated 18 July 2025. Submissions and evidence at the Hearing should be clearly directed to a nominated referred issue.
- 10. The VPA is to advise the Committee and parties how the issues referred to the Committee as listed in the letter referral to PPV dated 18 July 2025 should be interpreted or refined so that the sub category of 'tree protection' listed in the document entitled Summary of Responses, can be considered by the Committee.

Before the Hearing

Notice of the Hearing

11. The VPA must publish notice of the Hearing on its website, with information on how members of the public can observe it in person and online.

Information to be provided

- 12. The VPA must provide a map showing the location of submitters (including any late accepted submitters) to the Committee by 12 noon on Friday 5 September 2025. The Plan must:
 - identify submitters by submitter number, and not by name
 - b) be provided only to the Committee.
- 13. The VPA must provide a site inspection map and itinerary for the Committee to conduct its unaccompanied site inspection by 12 noon on Friday 5 September 2025. The map/itinerary must:
 - identify precinct submitters by submitter number
 - identify key precinct features relevant to submission issue focus include any sites identified by parties be provided only to the Committee.
- 14. All parties must advise the Committee of the following by 12 noon on Wednesday 27 August 2025:
 - the details of experts to be called including name and organisation, and the theme that the expert's evidence primarily relates to (refer to Table 1 in the VPA's referral letter)
 - confirm advocate details, distribution list changes, any advocate/expert availability changes
 - sites or precinct features to be included in the Committee's site inspection map and itinerary (please copy in the VPA's representatives in this advice).

VPA response to issues

- 15. The VPA must provide the following by 12 noon on Wednesday 3 September 2025:
 - a detailed response to issues raised in submissions
 - amended Plan 2, Place Based Plan in the PSP. If the completed updated plan is not available at that date, the draft current at that date should be circulated
 - a description of the major changes proposed to be made to the PSP including any updated plans.

VPA Part A (background and context) submission

- 16. The VPA must file a Part A (Background and context) submission by 12 noon on Thursday 11 **September 2025** that includes:
 - a summary of the physical context of the subject land and surrounds
 - b) background to the draft Amendment including chronology of events
 - a summary of the strategic context, including:
 - relevant planning policies and provisions

- (ii) any other recently approved or upcoming amendments that might impact on the Amendment
- d) a summary of any permit applications or recently granted permits that might impact on the draft Amendment
- e) a summary of the issues raised in submissions, including an explanation of which (if any) of those issues have been resolved and how

Note

The VPA's Part A (background and context) submission will be taken as read. The VPA should allow time for questions on Day 1 of the Hearing.

Day 1 version of documents

17. The VPA must file a Day 1 version of draft Amendment documents by 12 noon on Thursday 11 September 2025. These should track any changes proposed to be made to the referred documents resulting from further consultation or information received

Expert witness reports

- 18. All expert witness reports must be filed by 12 noon on Monday 22 September 2025.
- 19. An expert witness report must:
 - a) comply with the PPV Practice Note 1 Expert Evidence (Expert witnesses (planningpanels.vic.gov.au))
 - b) not refer to any individual submitter by name if necessary, individual submitters should be referred to by submission number. Community groups, organisations, corporations and government agencies can be referred to by name.
- 20. An expert witness who has not participated in a meeting of experts can provide a response to other like evidence by 12 noon the business day before the Hearing commences.

Expert meetings

- 21. Expert witnesses in the following areas must meet to prepare a statement of agreed opinions and facts. The nominated expert should act as a chair for the meeting and coordinate arrangements and note taking.
 - a) drainage, to be chaired and organised by the drainage expert nominated by Melbourne Water
 - b) roads and traffic to be chaired and organised by the roads and traffic expert nominated by the VPA.
 - c) After the town planning expert witness statements have been submitted and based on the range of issues addressed, the VPA is to determine whether the Committee would benefit from a meeting of the town planning experts. The VPA should arrange such a meeting if required.
- 22. The meeting(s) should be held after the expert reports are filed.
- 23. The meeting(s) can only be attended by:
 - a) the experts being called to give evidence
 - b) relevant staff from Melbourne Water for the meeting of drainage
 - a non-participating note taker if necessary.

Advocates or parties instructing the experts must not attend the meeting(s).

- 24. If any expert witness is instructed not to reach agreement in respect of points of difference, the expert must report those instructions in writing to the Committee and all parties.
- 25. The statement(s) of agreed opinions and facts:

- must list the relevant participants in attendance
- b) must note if any participant is not present for any significant discussion point
- must record the facts and opinions agreed and not agreed in respect of each issue and the reasons for any disagreement
- should be fewer than five pages with numbered paragraphs d)
- should not restate the evidence evidence should be cross-referenced in the agreed statement if required
- must be signed by all participants.
- must be filed by by 12 noon on Wednesday 1 October 2025.

At the Hearing

VPA opening submission

- 26. The VPA must present an opening submission on Day 1 of the Hearing that provides:
 - an overview of the Day 1 changes
 - the status of any unresolved issues referred to the Committee
 - its broad position in relation to the referred Table 1 issues.

Melbourne Water opening submission

- 27. Melbourne Water must present an opening submission on Day 1 of the Hearing that provides:
 - an overview of the relevant DSSs and any proposed changes in response to submissions
 - b) the status of the DSS which will apply to the Clyde South precinct
 - the identification of its outstanding drainage issues
 - its broad position in relation to the relevant referred Table 1 issues.

Other opening submissions

- 28. Other parties may submit a brief written opening submission where their position has changed as a result of further consultation or further advice. These opening submissions will be taken as read but the Committee may ask questions or seek clarification in respect of them at the Hearing.
- 29. Written opening submissions must be filed by 12 noon on Thursday 25 September 2025.

Presenting material

- 30. Submissions, presentations and other material presented to the Committee:
 - must be presented electronically
 - b) must be filed by 12 noon on the business day before the material is to be presented
 - should relate to the matters before the Committee c)
 - must include a summary of fewer than 5 pages if the material is more than 40 pages.
- 31. Submissions and evidence must be structured such that it responds directly to issues identified in the letter of referral from the VPA. Submissions and evidence seeking changes to the draft Amendment documents must clearly set in writing out what changes are proposed.

VPA Part B (main) submission

- 32. the VPA must address the following issues in its Part B (main) submission or through evidence:
 - Its response to submissions and evidence
 - Clarification of the current status of the proposed realignment of Clyde Fiveways Road and the proposed functional layout of the intersection of the South Gippsland Highway, Clyde Fiveways Road and Browns Road.

- C) The Committee recognises that there is an unclear line between suggested refinements to the proposed drainage scheme and proposed changes of a more substantial nature. Drainage proposals by submitters 20 (MAB), 21 (Galileo) which they describe as 'alternative schemes' appear to be substantial and refinements suggested by submitter 54 (Casey Council) appear to be a step change to the scheme proposed. In the view of the Committee, the proposed changes by Submitters 20, 21, 22, 23 and 54 could be considered as relevant to the issue of 'appropriate envelop and land take' as per item 1 in Table 1 of the referral letter. The VPA is directed to detail why the "envelope and land take" for the proposed drainage infrastructure is strategically preferred to an apparently reduced land take proposed by submitters 20, 21, 22, 23 and 54.
- d) In its submission Council notes, the Booring Recreation Reserve is located on the common boundary of the Botanic Ridge and Devon Meadows precincts. The Botanic Ridge PSP intentionally located this recreation reserve on the precinct boundary, anticipating that the recreation reserve would service a future residential precinct at Devon Meadows to the east. Can the VPA explain whether this was considered when developing the PSP and how this affected recreation reserve infrastructure provision in Devon Meadows.
- e) Its final position on the draft Amendment.

Other party submissions

- 33. A party who objects to the proposal must say how the proposal impacts them, how the proposal is inconsistent with Council or government policy or strategy, or both.
- 34. A party who intends to supplement their original written submission but not present at the Hearing must file their supplementary written submission by **12 noon on Tuesday 30 September 2025.**

Evidence and cross examination

- 35. Unless agreed by the Chair, evidence-in-chief should be no longer than 30 minutes for VPA witnesses and 20 minutes for other witnesses.
- 36. If an Expert witness is presenting on behalf of more than one party, 15 minutes may be added to these times in respect of each additional party being represented.
- 37. An expert witness may present a summary of their evidence at the Hearing, but it must:
 - a) not include new evidence
 - b) be filed by 12 noon the business day before that witness is scheduled to appear.
- 38. If giving evidence online, an expert witness must:
 - a) be alone in the room from which they give evidence and not make or receive any communication with another person while giving evidence except with permission from the Advisory Committee
 - b) inform the Advisory Committee immediately should another person enter the room from which they are giving evidence
 - not discuss their evidence with any other person during breaks in evidence when under cross examination
 - d) not have before them any document, other than their expert witness report and relevant supporting documents.
- 39. A party advocate and the Committee may question an expert witness. Cross examination should be restricted to 30 minutes
- 40. If cross examining an expert witness, a party must:

- be present for the whole of the expert witness giving their evidence
- b) ask clear and relevant questions, directed to matters of fact or professional opinion, that genuinely assist the Advisory Committee in understanding the issues
- allow the expert witness time to explain their answer. c)

Notes

The Chair will regulate cross examination. During the Hearing, the Chair may ask you how much time you will need for cross examining each witness, and will ask you to keep to your estimate. You should aim to complete your cross examination as concisely as possible.

Cross examination time may be limited.

You may be asked to move on to another topic if the line of questioning is not useful to the Committee.

Things to avoid when cross examining include:

- making a submission or providing your opinion
- giving extensive comment or context as an introduction to your question
- asking questions that are unrelated to the evidence
- arguing with the witness
- commenting on the expert or the evidence
- asking questions that have already been asked by another party.

If you do not support the evidence or basis on which it was prepared, or consider the evidence should not be given weight, detail your reasons in your submission rather than raising these issues in cross examination.

If you are not experienced in cross examination, you are encouraged to write your questions down to ensure they are succinct, structured into themes and able to be asked without long explanations of the context.

Part C (closing) submissions

- 41. The VPA, Melbourne Water and Council will be provided time to present a Part C (closing) submission. The Part C (closing) submissions:
 - a) must not raise new matters
 - b) may respond to matters raised in other parties' submissions or evidence
 - identify any final proposed drafting changes to the Day 1 documents
 - the VPA is to include its final version of the Amendment documentation. The final version must:
 - be labelled 'VPA Part C (closing) version Clause/Document X' (i)
 - (ii) be in the form of or accompanied by a table which sets out the changes proposed from the VPA Day 1 version.
- 42. Parties wishing to provide drafting comments must do so within three working days following receipt of the VPA's Part C (closing) version of documents. This will be confirmed by the Committee on the final day of the Hearing. Drafting comments must only relate to drafting issues, not broader issues.
- 43. The VPA may make further comment on changes proposed by parties and file them a further two business days after comments from submitters have been received.

Privacy and use of personal information

- 44. A party must not record, keep, distribute or publish contact details of any other party obtained during the Advisory Committee process, or use those contact details for any other purpose.
- 45. A party must not record any part of a Hearing by any means without permission from the Chair. This includes the use of notetaking apps and similar AI based recording mechanisms.
- 46. A party who wishes to record the proceedings must make a request to the Chair at least five business days before the Hearing commences, outlining its reasons.
